Our bylaws state we follow Roberts Rules, but do we? Not always. When communication breaks down and meetings go off track, it is an indication we have strayed from the structure provided by Roberts Rules and best practices.

2021 is shaping up to be another COVID-19 year. Teleconferences are here for the foreseeable future, and so are the challenges of conducting meetings using technology.

Trying to ensure that everyone has a say, equally distributing speaking time, and efficient, well-run meetings are a challenge. Going forward the focus will be on our agenda, which is our roadmap.

Our meetings are divided into officer reports, old business, and new business. We will now add a 3-minute comment period. A member may use their 3 minutes following the conclusion of **New Business**. This will permit our meeting to remain focused and on topic. Alternatively, members can raise concerns and comments via email to the Board and/or request a topic be added to a future agenda. Agendas will be distributed at the time meetings are announced, 10-days prior to a meeting.

Use Email to send questions, comments, and input to the Board. Using email:

- Let the Board assign the question or concern to a responsible party, most knowledgeable.
- It provides time to conduct research if necessary.

If a member has a compliment or a criticism, they wish to voice, they may do so during the 3-minute comment period.

Member Questions

Questions and answers from the last general meeting:

WHY ARE WE USING PAYPAL?

This question was asked in several ways:

Why are we using PayPal? Where is our governing docs (by-laws) is this authorized)? Is there any type of comingling or issues as to how the PayPal label appears? Comment about members not liking or using PayPal.

- 1. We are using PayPal to better serve our members who have requested payment processing. In this case, using PayPal to pay for their membership. It is not mandatory, and no one is being forced to use PayPal, it is a convenience.
- 2. Our governing docs do restrict the use of PayPal or similar types of technologies. We can look to precedence when credit cards were opened by an officer of club. If a member feels like it should be included into our governance, that is certainly an option to consider.

When members went to use PayPal they noted a reference to labeling using our Health Trust name. There is no comingling of funds and our Treasurer is able to see which transaction is designated as a Health Trust donation versus an annual membership due.

3. The Board has not received any complaints from members choosing to use PayPal. Quite the opposite, it is convenient. Since you can pay by check and pay for postage, visit the Post Office during Covid-19, I believe this is commendable that our Treasurer has proactively implemented PayPal.

WHY IS THE PRESIDENT SENDING OUT MEETING ANNOUNCEMENTS?

- 1. One, we have a precedence from past presidents, so this is not unusual.
- 2. The President is not restricted in any of the governing documents from sending out an announcement. Unless prohibited, your elected President exercises the same powers a CEO would of a company. As such, many functions, in fact most, are not clearly defined.

There may be times when an officer is not available, the organization should not grind to a halt, so unless an action is expressly prohibited, this practice will continue as needed.,

WHY HAS THE WEBSITE NOT BEEN UPDATED, NOTHING HAS BEEN DONE SINCE IT WAS MOVED TO A NEW HOST.

- 1. Our website has been updated. Please check it out. Example, you will now see a link for our BayScot Bulletins to be accessible through this link. This is especially useful to new prospective members and existing members whose email with attachments are flagged as Spam email.
- 2. Our website, like the SFBSTC Facebook account, and our financial records, our club documents were not properly transitioned from the 2019 administration to the new 2020 administration. The time and effort this has taken to correct, such has re-typing documents from hardcopy, .website access and domain registration, and so on remain issue we continue to address. With

the help and outstanding efforts of Cynthia Mason, Sherry Shepardson, and Jon Garside we have made great progress.

- 3. Our Board is working to put in place measures to guard against situation where SFBSTC records, and property are protected.

Legislation

California Bill Seeks to Regulate All Dog Breeders

----- AKC LEGISLATIVE ALERT

A bill was introduced in the California legislature to regulate all who breed a dog in California. This bill would require all who own an intact dog to obtain a permit. It is unknown at this point who and how these permits will be issued and by whom.

"A permit would be required for any person who owns, possesses, or harbors an unaltered dog or cat for the purpose of breeding. It is assumed this would include stud dogs and dogs being kept temporarily for breeding.

How much will it cost?

The cost will be determined by individual jurisdictions. The bill states the cost may not exceed "reasonable costs of administering" the program. The state does not provide funding to localities for implementing or enforcing the measure, but allows them to raise funds through fees, etc. to do so."

What You Can Do:

As stated above, this is an opportunity to educate lawmakers on this issue and the negative impact it could have on responsible breeders in the state. Those who wish are encouraged to respectfully do the following: **Contact Assemblyman Miguel Santiago, author of AB 702.** Let him know you are a responsible breeder in California and respectfully ask that he not allow this bill to move forward. Contact your Assembly Member. Let them know you are a constituent and express your concerns with this bill. 

New Ideas for Meetings and Activities

This pandemic certainly has had it downside, but we've had to adjust. Teleconferencing and Zoom offers convenience, even with some of its inherent problems. An idea is to use Zoom to bring a guest speaker, or panel of experts into our club activities. In the past we have had to find a physical site, then drive to inconvenient places for a meeting or event. Zoom has the advantage of bringing the talent to us.

Zoom Guest Speaker

This idea is modeled after the TED talks, but scalable to our needs and resources. Our experts may be veteran breeders, veterinarians, judges, from national and regional clubs who could dial in and be part of Zoom event.

Example, some of us have been discussing why some Scotty litters consistently product large litters of puppies, why? What are the determinant factors for a litter all wheaten? With the flexibility of Zoom we could partner with one, two, three regional clubs to create panel discussions, bring in an expert, and so on.

One format might begin with a 10:00 am General Meeting, and at 11:00 am we dial into the second part of our meeting with a genetics expert panel, dog behavior specialist, and so on.


Sample: Zoom Panel with Guest Speaker Panel shared with 2 other regional clubs




Figure 1. General Meeting Overview




Figure 2. General Meeting Format




Figure 3. General Meeting Communication Flow
